Under Clause 14 of the Planning, Development and Infrastructure Regulations, an order be made that Item 2.1, including the report, attachments and discussions having been dealt with in confidence under Clause 13(2)(a) of the Planning, Development and Infrastructure Regulations, shall be kept in confidence until a decision of the Environment, Resources and Development Court relevant to the item is made.
- 3. Further, that at completion of the confidential session, the meeting be re-opened to the public.
