WORKSHOP / PRESENTATION ITEMS

Presentation by Jeremy Conway, Chief Executive, Infrastructure SA

Report Reference: ISC201006R01

Jeremy Conway, Chief Executive Officer Infrastructure SA presented on the priorities of Infrastructure SA and potential opportunities that link to Local Government.

The following discussion points were noted:

- Shovel ready projects and what that means. Maintenance projects are a good example of shovel ready vs the planning required for construction projects.
- Local Government is in a good position to have projects ready at short notice. Concern that
 projects put forward get lost in the process. Benefit of independent advisory (Infrastructure
 SA) the advice goes straight to the Premier.
- Govt reviewing strategy before submitting new projects to Infrastructure Australia. IPL does
 not get funding but demonstrates the State Govt has invested in planning providing
 creditability for the project and facilitates conversations with the Commonwealth.
- South Road corridor DPTI undertaking detailed planning. Due to the scale of the project and the need to get the decision right, it's likely to be mid next year before final decisions are made. Design considerations include balancing cost efficiency of staying underground with egress points.
- Quality of life metrics included in assessment frameworks. Build infrastructure for a reason that add genuine benefits to the community. Key is to ensure consultation is done well.
- Tonsley precinct is important in SA context along with the other innovation precincts. They
 all have a different role and should compliment each other. Key is to drive economic
 growth in Adelaide.
- Infrastructure SA legislative mandate is major infrastructure projects over \$50M.



- Members raised some points of frustration including DPTI's decision to not include carparking at Tonsley railway station, length of time to approve changes to planning zones and opportunities to reuse recycled materials.
 - P&D code may go some way to provide more flexibility in addressing the rezoning changes.
 - The need for reprocessing facilities will grow and Infrastructure SA would support this however need to build a case beyond pure job numbers.
- Open door policy at Infrastructure SA however most appropriate time to lobby projects is during the development of the Capital Intention Statement (AUG-OCT). During this time, ISA assess and formulates the list to take to Cabinent.
- Recognise that renewable energy is going to increase. Council are energy users and can contribute by having smart appliances, manage energy load in an integrated way ie own powerplant, opportunities for solar power.
- NBN next phase rollout still in early planning stages. Rollout of 5G may offer Council an
 opportunity to play a role ie smaller installations rather than big towers and Council has a
 lot of assets that may be able to assist with.

- Trialing street light technology with 5 lights along Diagonal Way.

- Provide clear and specific scope for presenters to address. At the end of presentations identify next steps for the Committee to provide advice and recommendation to Council.
- Truly strategic issues better discussed in a forum where whole of Council can attend.
