- Recommend to Council that a recruitment process be undertaken by the Committee for an Independent Member on the Finance, Risk and Audit Committee for a term commencing 1 December 2024 to 30 November 2027.
- Recommend Council increase the remuneration payable to Finance Risk and Audit Committee members to \$1200 per meeting for Independent Members, and \$1500 per meeting for the Chair in accordance with Section 3.13 of the Finance, Risk and Audit Committee Terms of Reference.
- 4. In accordance with Section 91(7) and (9) of the Local Government Act 1999 the Committee orders that this report, 'Finance, Risk and Audit Committee Independent Member and Chair RSC240806F5.1' any attachments and the minutes arising from this report, having been considered in confidence under Section 90(2) and (3)(a) of the Act, except when required to effect or comply with the Committee's resolution(s) regarding this matter, be kept confidential and not available for public inspection upon the basis that the information relates to the performance of the Committee and its members.



- 5. This order shall operate until it is revoked or a further order is made and will be reviewed every 12 months.
- 6. Pursuant to section 91(9)(c) of the *Local Government Act 1999*, the Committee delegates the power to revoke the confidentiality order to the Chief Executive Officer.
